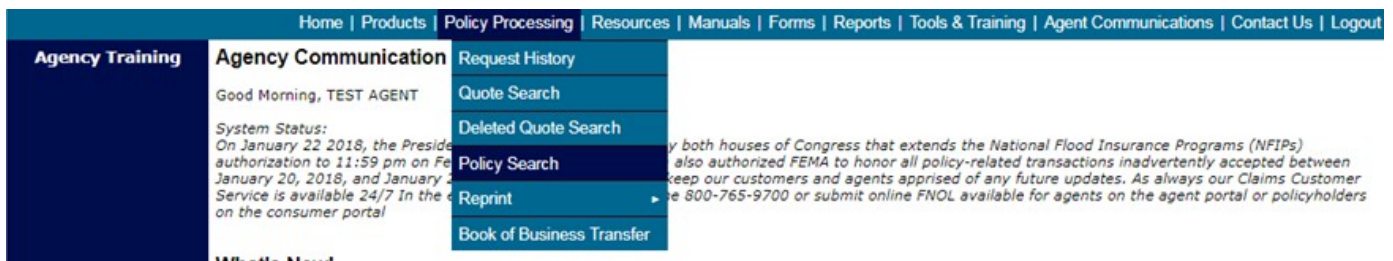


Viewing Homeowners Inspections

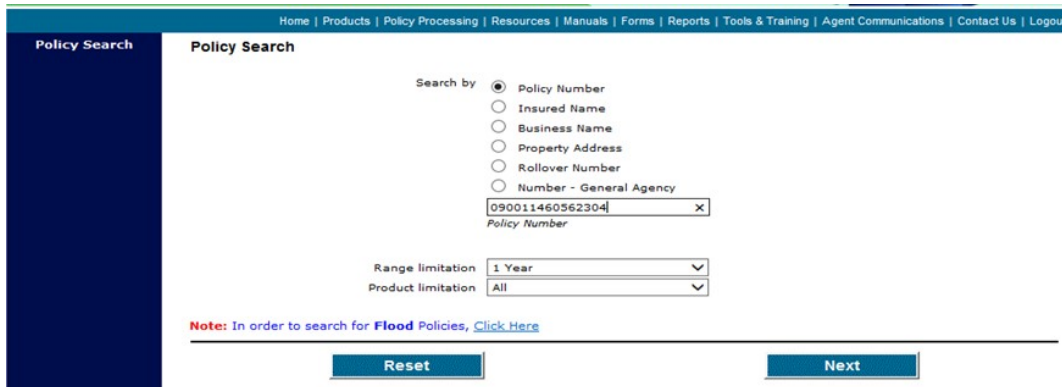
1. Log into the [Bankers' Agent Portal](#)
